RE: Estimated Federal Title Program Allocations (SY 11-12)

The 2011-2012 Estimated Federal Title Program Allocations will be posted on DPI's website at <http://www.dpi.state.nd.us/grants/NCLB.shtm> within the next couple days. I have also attached a copy of the file to this email for you to view. Please note that these are only estimated amounts and generally the final allocations vary some from these estimates. I am anticipating that I should have final allocations available by early July. As soon as the final allocations are available, I will send a follow up email and also pre-populate the final allocations into the consolidated application.

Title IID was not funded this fiscal year by the US Department of Education so there are no allocations for the Enhancing Education Through Technology Program. However, if your school district chooses the REAP or Transferability flexibility option, funds can still be REAPed or Transferred into Title IID activities.

The electronic consolidated application has also been opened for data entry to the 2011-2012 school year. The estimated allocations have been pre-populated into the applications to allow school district personnel to start working on SY 11-12 applications. Since the allocation amounts are estimates, ***please do not submit your application***. Once you have been notified that the final allocations have replaced these estimates in the application, you may make necessary adjustment for any changes in funding and submit. All consolidated applications must be submitted in STARS by **Friday, August 26, 2011** and no applications will be accepted after that date. The Electronic Consolidated Application Help Screen document is posted on DPI's website at <http://www.dpi.state.nd.us/grants/NCLB.shtm> under Resources and Forms. When choosing activities on the application, please read through the activity listing to make sure you are choosing the correct activity ID code that matches the activity you plan to do. In addition, I strongly encourage you to put additional narrative about each activity in the textbox provided to help minimize our potential questions.
